Dear Huw

On 16 March, it was confirmed the Retained EU Law (Revocation and Reform) Bill ("the Bill") will commence Report Stage in the House of Lords on 19 April. We have, therefore, been able to move the Senedd debate on legislative consent from 21 March to 28 March.

At Business Committee on 14 March, supplementary Legislative Consent Memorandum No. 4 for the Bill was referred for reporting with a deadline of 20 March. Given the movement of the debate, I would now recommend a revised reporting deadline of 27 March.

I appreciate this remains a limited period, but hope this additional time allows your Committee to consider and report on Memorandum No.4 ahead of the debate on this important piece of legislation.

I am copying this letter to the Llywydd and will inform Business Committee of this development at its 21 March meeting.
