Scrutiny of the Welsh Government's Draft Budget 2021-22 / COVID recovery action plan

In October 2020, we wrote to Jeremy Miles MS, the Counsel General and Minister for European Transition, inviting him to attend Finance Committee in relation to the Welsh Government's Draft Budget 2021-22, in his role in co-ordinating Wales' recovery from the COVID-19 pandemic.

During **questions** to the Counsel General in Plenary on 11 November 2020, the Counsel General stated that his responsibilities in relation to COVID recovery "have concluded with the publication of the action plan at the beginning of October".

As a Committee, we were surprised that the over-arching responsibility for ensuring the action plan's success didn't fall within the remit of a specific Minister and we subsequently wrote to the First Minister to seek clarification.

In his **response**, the First Minister stated:

"It is essential Covid recovery is taken forward by all the Welsh Government and are not regarded as the preserve of a single Minister. Our priorities for recovery stretch across all our functions as a government, both now and into the future."

While acknowledging this collective approach, the Committee is very concerned that no specific Minister is directly accountable for COVID recovery work. Without this overarching role in place, the Committee has found it challenging in undertaking effective scrutiny of the Welsh Government's Draft Budget 2021-22, a budget which has undoubtedly been affected by the ongoing uncertainty arising from the COVID-19 pandemic.

As it is widely considered that the COVID-19 pandemic will be here for some time and will have a significant impact on the Welsh Government's proposals for future allocation of funding and resources, the Committee is concerned that there is no overarching responsibility to ensure the successful implementation of the recovery plan.
