On 2 July the Business Committee allocated Legislative Consent Memorandum for the Non-Domestic Rating (Public Lavatories) Bill to the Economy, Infrastructure and Skills Committee. The reporting deadline given was 2 July. The Bill this LCM relates to is a reintroduced Bill which was guillotined as a result of the 2019 general election.

When the Committee discussed the LCM in its first iteration we found no reason to object to the Assembly, as it was then, agreeing the Legislative Consent Motion associated with the Memorandum.
