Re: Winter preparedness inquiry

Thank you for your letter of 30 January 2019 regarding winter preparedness. I am pleased to provide the following response.

Powys Teaching Health Board (PTHB) does not have a DGH or A&E department within its Health Board area, however I outline for the Committee the work that we have been focusing on in Powys with our partners. We are clear as a commissioner of acute care services and a provider of community services that our role is that of a supportive partner working with our neighbouring Health Boards across Wales and NHS Trusts across the border in England. The key aim is to improve access for patients to care and support across the system making sure that patients receive the right care, in the right place.

The aim of our winter resilience plan and the unscheduled care programme is to ensure clear and supportive actions are in place across the system, enabling care close to home and to reduce avoidable admissions into more acute levels of care. The focus of our partnership work is to ensure that services are available across Primary and Community care that:

- Reduces avoidable unscheduled care demand and the need for Powys patients to attend neighbouring A&E departments
- Allow timely and safe transfer back to the community
