Summary of issues discussed:

Dr Jill Newman gave a presentation about the work undertaken to scope the workforce requirements of potential future hyperacute stroke units in Betsi Cadwaladr Health Board.

JN highlighted that final decisions on the number of hyperacute units in north Wales had yet to be taken and outlined the principles being used during the redesign of units and the proposed service model. She suggested implications on the workforce and also gave attendees detail on the whole system requirements, including those around the post-acute pathway.

MO presented on the issue of post-acute stroke workforce and rehabilitation. He explained that the Cross Party Group on Stroke was taking a whole pathway approach to workforce, including acute and post-acute workforce in the same meeting. The Cross Party Group had covered stroke workforce in previous meetings. He presented recent SSNAP figures and the 2015 post-acute audit.

Action: Chair to write to local health boards asking for results of multidisciplinary, neuro-rehabilitation work and hyperacute unit modelling funded by the Stroke Implementation Group.

Summary of issues discussed:

SM and RW presented on the findings of the recent Independent Accelerated Programme for Amber Review. The model in Wales appeared to be more target driven, designed to respond to saving life. Harmonisation of opening hours of eg injuries units, was universally agreed as the best practice in Wales, as services varied considerably according to the locality. Service quality measures were considered as crucial in reviewing the patient pathway and also for partnership working with other clinicians. Checks should be implemented to ensure that unacceptable waiting times do not occur, and that no harm is inflicted onto the stroke survivor that can be avoided.

There was discussion over whether the appropriate clinical response should be within the red or amber category.

KC stated that the Stroke Association's aim is to work with the ambulance service in order to set appropriate targets to bring the service in line with services in the UK.

SM suggested that targets can take the focus away from treatment needed; the key question is, what is important and how do we measure it? MO stated that the Stroke Association welcomes the 'whole episode' measure and is satisfied with the current amber classification. He also welcomed the pro-active engagement with those conducting the Review. However, he disputed the assertion there was no evidence for targets.

DF stated that his family has had a major call on ambulance services and he had observed lines of ambulances waiting to offload patients outside his local hospital on many occasions. Eradicating delays would help the patient experience run more smoothly.

Action: Chair to write a letter to the Cabinet Secretary to highlight the discussion points made and ensure appropriate consideration is given by the Cabinet Secretary.

Summary of issues discussed:

Annual General Meeting

Katie Chappelle nominated Dr Lloyd AM for the role of Chair for the forthcoming year. The nomination was seconded by several Members and Dr Lloyd accepted the position.

The secretariat role would be continued by the Stroke Association. Jillian Haynes would be standing down after two years and Matt O'Grady would take over the position. Dr Lloyd thanked Jillian for her support.

Katie Chappelle presented the Annual Report and the Financial Report to the Chair.

Meeting: 12 March 2019

Dr Jones gave a presentation on the Stroke Delivery Plan and work achieved to implement it to date. Dr Ahmad updated on atrial fibrillation and progress towards thrombectomy services for Wales.

Ms Pippa Ford enquired about the future of the Stroke Delivery Group and Stroke Implementation Group and future funding. Dr Jones stated that there was no guarantee that the money would continue after the financial year (2020-21). Dr Fiona Jenkins stated that Chief Executives were reviewing the function and roles of all the national major conditions delivery groups, but did not yet know the result of their considerations. She added that focussing on stroke solely, had enabled the Stroke Implementation Group to be effective. Discussion was also held on progress towards HASUs in Wales.

Matt O'Grady presented a paper on the proposed workplan for the Cross Party Group next year. A format change was proposed: rather than selecting several issues for examination throughout the year, it was suggested that one issue only be reviewed per year and followed through so that attention could be focussed on obtaining specific results eg the Stroke Delivery Plan outcomes since its formation. Suggestions were offered for discussion.

The new format was agreed by Members and the focus for 2019-20 would be to monitor the progress of discussions and analyse improvements created by the Stroke Delivery Plan.

Discussion was held on what the priorities of the inquiry should be. It was agreed that the Cross Party Group on Stroke inquiry into the Stroke Delivery Plan would focus on four areas: 1) stroke prevention, 2) fast, effective stroke care, 3) life after stroke and 4) the future of the Stroke Delivery Plan.

Matt O'Grady stated that the current Task & Finish Group, which heretofore comprised of Dr Anne Freeman, Pippa Ford and Nicola Davis-Job, as well as Stroke Association colleagues, was open again to anyone who would like to participate. Emma Henwood stated that her British Heart Foundation colleagues would like to be considered and David Fitzpatrick also expressed an interest.

The next Cross Party Group on Stroke meeting would be held in June on a date and venue to be advised via the Cross Party Group on Stroke website.
