**The Public Health (Minimum Price
for Alcohol) (Wales) Act 2018
(Commencement No. 2) Order 2020**

EXPLANATORY NOTE

(This note is not part of the Order)

This is the second commencement order made by the Welsh Ministers under the Public Health (Minimum Price for Alcohol) (Wales) Act 2018 (“the Act”).

The Act makes provision about the minimum price for which alcohol is to be supplied in Wales by certain persons; and for connected purposes.

Article 2 provides that 2 March 2020 is the appointed day for the bringing into force of all provisions of the Act set out in that article and referred to below—

- (a) section 1 for all remaining purposes;
- (b) sections 2 to 25;
- (c) Schedule 1.

This Order brings into force the remaining provisions of the Act which are not already in force.

Provisions coming into force on 2 March 2020

2. The following provisions of the Public Health (Minimum Price for Alcohol) (Wales) Act 2018 come into force on 2 March 2020—

- (a) section 1 for all remaining purposes;
- (b) sections 2 to 25;
- (c) Schedule 1.
