2 New petitions

2.1 P-05-704 Bring Back January Exams for AS/A level Students

The Committee considered the petition for the first time and agreed to await the views of the petitioner before deciding whether to take any further action.

2.2 P-05-707 Teachers' Training Must Include Statutory Training in Autism

The Committee considered the petition for the first time and agreed to write to the Cabinet Secretary for Education to ask whether the Government intends to address the issues of autism in teacher training through the forthcoming Additional Learning Needs and Education Tribunal Bill, and the planned timetable for this.

2.3 P-05-709 The Circuit of Wales

The Committee considered the petition for the first time and agreed to write to the Auditor General and the Public Accounts Committee asking them to take the petition into account in their consideration of the Circuit of Wales project.

2.4 P-05-710 Ensure Disabled People can Access Public Transport As and When They Need it

The Committee considered the petition for the first time and agreed to invite the petitioners in to provide further evidence to the Committee.

2.5 P-05-711 Ensure Disabled People's Housing Adaption Needs Are Adequately Met

The Committee considered the petition for the first time and agreed to seek the views of:

- the petitioners on the new framework for home adaptations currently being implemented; and
- the Welsh Local Government Association (WLGA) and Disability Wales on the issues raised by the petition and the implementation of the new framework.

3.4 P-05-693 Give Every Child in Wales the Meningitis B Vaccine for Free

The Committee considered correspondence on the petition and agreed to write to Meningitis Now and the Meningitis Research Foundation to seek their views on extending the existing vaccination programme.

3.5 P-04-519 Abolition of Park Homes Sales Commission

The Committee considered correspondence on the petition and, now that research into the economics of the park homes industry has been published by the Welsh Government, agreed to write to the Cabinet Secretary for Communities and Children to seek the Government's reflections on the recommendations in relation to the ability of site owners to charge commission on the sale of park homes.
